Personal data that we process

Gulje Maritiem processes your personal data because you use our services and/or because you provide it to us yourself.

Below you will find an overview of the personal data we process:

- First and last name
- Phone number
- E-mail address
- Bank account number

Special and/or sensitive personal data that we process

Our website and/or service does not intend to collect data about website visitors under the age of 16, unless they have permission from their parents or guardian. However, we cannot check whether a visitor is older than 16. We therefore advise parents to be involved in the online activities of their children, in order to prevent data about children from being collected without parental consent.

If you are convinced that we have collected personal information about a minor without this permission, please contact us at info@guljemaritiem.com and we will delete this information.

For what purpose and on what basis do we process personal data

Gulje Maritiem processes your personal data for the following purposes:

- Handling your payment
- To be able to call or e-mail you if this is necessary to carry out our services
- Gulje Maritiem also processes personal data if we are legally obliged to do so, such as data that we need for our tax return.

Automated decision making

Gulje Maritiem does not make decisions based on automated processing on matters that can have (significant) consequences for people. These are decisions taken by computer programs or systems, without involving a person (for example, an employee of Gulje Maritiem).

How long we keep personal data

Gulje Maritiem does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected. We use a (legal) retention period of 7 years for the personal data mentioned:

Sharing personal data with third parties

Gulje Maritiem only provides to third parties if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

Cookies, or similar techniques, that we use

A cookie from the American company Google is placed via our website as part of the "Analytics" service. We use this service to keep track of and receive reports on how visitors use the website. Google may provide this information to third parties if Google is legally obliged to do so, or insofar as third parties process the information on Google's behalf. We have no influence on this. The information that Google collects is anonymized as much as possible. Your IP address is expressly not provided. The information is transferred to and stored by Google on servers in the United States.

View, modify or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Gulje Maritiem and you have the right to data portability. This means that you can submit a request to us to send the personal data we hold about you in a computer file to you or another organization mentioned by you.

You can send a request for access, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to info@guljemaritiem.com.

To ensure that the request for inspection has been made by you, we ask you to enclose a copy of your proof of identity with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy. We will respond to your request as quickly as possible, but within four weeks.

Gulje Maritiem would also like to point out that you have the option of submitting a complaint to the national supervisory authority, the Dutch Data Protection Authority. This can be done via the
